- An original bank statement (or certified copy) on bank stationery in your or your family's name. The statement must be issued within the last six (6) months and include your current balance in US dollars.
- A photocopy of a scholarship letter in your name for study at Yale University.
- If you are going to be supported by a US citizen or US permanent resident family member or friend, your sponsor must complete A U.S. Affidavit of Support Form (USCIS form I-134) accompanied by original financial documentation as required on the form.
